(57) **CLAIM**

The ornamental design for a pipe fitting, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pipe fitting;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a front elevation view thereof, with the rear
elevation view being a mirror image;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a front sectional view thereof along line 8-8 of FIG.
1.
